1 **JUDGMENT**

2 In accordance with, and for the reasons stated in the Final Approval Order, judgment shall  
3 be entered whereby Named Plaintiffs and all Settlement Class Members shall take nothing from  
4 Defendant EUROMARKET DESIGNS, INC., an Illinois corporation d/b/a CRATE & BARREL  
5 and CB2 except as expressly set forth in the Amended Stipulation and Settlement Agreement of  
6 Class Action Claims, which was previously filed with the Supplemental Declaration of Edwin  
7 Aiwazian in support of Plaintiffs' Motion for Preliminary Approval and Certification of the  
8 Settlement Class.

9 This Judgment does not apply to those individuals who were excluded from the Class in  
10 accordance with the Final Approval Order.

11 Pursuant to California Code of Civil Procedure Section 664.6 and Rule 3.769(h) of the  
12 California Rules of Court, this Court reserves exclusive and continuing jurisdiction over this  
13 action, the Named Plaintiffs, Members of the Class, and Defendant for the purposes of:

- 14 (a) supervising the implementation, enforcement, construction, and interpretation of  
15 the Settlement Agreement, the Preliminary Approval Order, the plan of allocation,  
16 the Final Approval Order, and the Judgment; and,  
17 (b) supervising distribution of amounts paid under this Class Settlement.
